Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The Novel coronavirus. COVID-19 has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Braintree Babe Ruth has put in place preventative measures to reduce the spread of COVID-19: however, Braintree Babe Ruth **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. **Attending Braintree Babe Ruth could increase** your risk and your child(ren)'s risk of contracting COVID-19

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 while attending Braintree Babe Ruth games and or practices and that such exposure or infection may result in personal injury, illness, permanent disability, and potential death. I understand that the risk of becoming exposed to or infected by COVID-19 at Braintree Babe Ruth may result from the actions, omissions, or negligence of myself and others, including but not limited to, Braintree Babe Ruth volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance with any **Braintree Babe Ruth** sanctioned event.

On my behalf, and on behalf of my child(ren), **I hereby release**, covenant not to sue, discharge, and hold harmless Braintree Babe Ruth, its volunteers, coaches and board of directors including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on actions, omissions, or negligence of Braintree Babe Ruth, its volunteers, coaches, and board of directors, whether a COVID-19 infection occurs before, during, or after participation in any Babe Ruth game, practice, or event. I also agree that **Braintree Babe Ruth** has the right to remove myself, my child(ren) or any member of my family should we be found to not be following the proper guidelines set forth by Braintree Babe Ruth in regards to social distancing, sanitization, equipment sharing, mask wearing, ride sharing.
